Application Fee: \$310

A variance is a modification of the requirements of an ordinance as to lot size, lot coverage, width, depth, front yard, side yard, rear yard, setbacks, parking space, height of buildings, and other ordinance provisions. A variance shall not be considered a right or special privilege, but may be granted to an applicant who shows that undue hardship would result because of characteristics of the site or structure and that a variance is not in conflict with public interest. In order to obtain a variance, an applicant must demonstrate the following:

- 1) That special conditions and circumstances exist which are peculiar to the land, structure, or building involved and which are not applicable to other lands, structures, or buildings in the same district:
- 2) That liberal interpretation of the provisions of this ordinance would deprive the applicant of rights commonly enjoyed by other properties in the same district under the terms of this ordinance;
- 3) That the special conditions and circumstances do not result from the actions of the applicant;
- 4) That granting the variance requested will not confer on the applicant any special privileges that is denied by this ordinance to other lands, structures, or buildings in the same district. No nonconforming use of neighboring lands, structures, or buildings in other districts shall be considered grounds for the issuance of a variance.
